2018 Registration Enrollment/Terms/Conditions

EARLY BIRD OPTIONS and BALANCE DUE DATES (2018 rates will apply if balance due deadlines are not met)

Receive a 6% reduction in rates: Enroll for 4 or more weeks by **December 15** (*postmark*), and receive a 6% discount. Payment in full is due by *May 1, 2018*

Receive a 3% reduction in rates: Enroll for 2 or more weeks between December 16 and January 31 (*postmark*) and receive a 3% discount. Balance due *May 15, 2018*

Enroll **after January 15** and 2018 rates apply. Balance due by June 1, 2018

REDUCTION IN WEEKS NOTICE – IF you are considering reducing weeks due to vacation or other upcoming events, sign up for fewer weeks and then add later. As per our terms, there will be no refunds, transfer of funds, etc., for days or weeks not attended. Additional weeks can always be added without penalty, pending availability, of course. See “April 1” below.

ENROLLMENT PROCEDURE, TERMS, AND CONDITIONS

- Complete and sign the enrollment card and send to the camp along with a non-refundable deposit of **\$400** per camper (or **\$150 for each week** of enrollment) per camper; make checks payable to "Winnewald Day Camp." For Credit Card transactions, a 3% convenience fee will be added.
- Any enrollment changes must be requested in writing via e-mail to **winneday@ptd.net**
- **March 1, 2018**
 - **Payment Due** – \$100 for each week of enrollment per camper
 - **Submit Health Form*** (on web site) for each camper; a doctor's signature/physical exam is NOT required. If camper has an IEP, 504, or medical management plans, see reverse side of sheet.
- **April 1, 2018**
 - A **reduction in the number of weeks** enrolled will result in application of 2018 rates **plus \$50 per each week reduced**.
- **May 1, 2018**
 - The 6% reduction rate schedule balance due date. Failure to pay by due date will result in 2018 rates.
- **May 15, 2018**
 - The 3% reduction rate schedule balance due date. Failure to pay by due date will result in 2018 rates.
- **May 31, 2018**
 - All evening activities must be pre-paid in order to receive the reduced price (magic tournament – one fee).
- **June 1, 2018**
 - **All balances** must be **paid IN FULL** unless a no-interest **payment plan** has been previously arranged.
 - Payment is due by check/cash; if not received, the amount specified will be charged to your credit card on file with a 3% convenience fee added.
 - NO refunds or transfer of funds will be made for schedule changes, withdrawal, dismissal, days absent, missed days, or incomplete attendance. There are no make-up days for any days missed.
 - Health, medication authorization, and epi-pen forms are due.
 - A 2 percent per month carrying charge or \$4 minimum will be applied to past-due balances.
 - Evening activity fees will be increased by \$5 per activity. Cancellation refunds will be issued only if request is e-mailed one week in advance of the scheduled activity.
 - Campers unable to fulfill their campership due to a doctor-certified illness will receive a partial credit for the following season. The doctor's note (on professional letterhead) must state reason, days missed due to illness, and doctor's signature.
 - A charge of \$20 will be levied for any checks returned due to insufficient funds.
- **No camper will be permitted in camp without:**
 - (1) a health form on file and (2) balance paid in full or a payment-plan on file.

***Deadlines for reduction in rates will be strictly enforced.**

For Campers with an IEP, 504, or Medical Management Plan

- If the child has an IEP, a 504-accommodation plan, or a Medical Management Plan, final acceptance into camp will be made pending review of these documents which must be submitted 4 weeks prior to the beginning of the camper's enrollment.
- A personal interview will be scheduled with the parent and prospective camper.
- Completion of the Medical Management Plan Form and Release Form, if necessary.
